Items should be removed under strict supervision of the officer's represents from sub departments of the items available and Railway Protection Force (RPF). Please note that removal of items should be arranged without any damages to the Railway Properties.
05. The Security Bond will be returned only after removal of total quantity and on successfully completion of the disposal.
06. This Letter of Award, Railway Conditions of Contract together with your Bid dated **28.11.2023** and your acknowledgement to this letter of award and the Security Bond shall form a contract binding on both parties until such time a formal contract agreement is executed.
