Concrete Sleepers to Sri Lanka Railways or have supplied Pre-stressed Concrete Beams for a value of more than Rs. 50 million or should have supplied Pre-stressed Concrete Poles for a value of more than Rs. 500 million within the last five years along with the copies of invoices.
