It will be drawn your attention towards the circular of the General Manager - Railways, No.G.M.R./C.A.R.(R.II) 01.01/2016 dated 31.12.2016 issued on the above matter.

In II.01 of that circular, it should be clearly mentioned the Ministry of issuing warrants / Department Expenditure Head / Programme / Project & that "1003 which is the object code for other allowances should be indicated as the object code" will be amended as object code 1401 - Transport with effect of January 2018. Accordingly, it is kindly informed to take the necessary actions.

03. Accordingly, please take into consideration that any institute in the central government should not make payments for Railway warrants in 2018 through cheques & accounting will be done by the department of Railways using account summaries.

04. This circular is issued with accord of the Treasury & these provisions will be come into force with effect from 01.01.2018.
