Invitation of Bids by the Procurement Committee for leasing the rest rooms with the restaurant in several Railway Stations belonging to the Railway Department

The chairman, the Departmental Procurement Committee on behalf of the Sri Lanka Railway Department invites sealed bids from qualified and experienced Bidders to lease the below cited rest rooms with the restaurant in several Railway Stations, for a period of five years on a business purpose.

Serial Number	Rest Rooms with the Restaurant
01	The Restaurant and 10 rest rooms- Batticaloa
02	The Restaurant and 18 rest rooms- Polonnaruwa
03	The Restaurant and 06rest rooms- Trincomalee

Details on the above cited Rest Rooms with the Restaurant has been indicated in the schedule 1 under the procurement documents.

01. Eligibility

Should be a Sri Lankan citizen.

It should be possessed a valid registration as a business relevant to the field concerned with one year experience and it should be produced bank statements of 03 consecutive months to establish financial stability.

02. Obtaining Bidding Applications

Procurement documents can be obtained from the office of Railway Sales & Marketing or the Railway Station where the relevant Rest Rooms with the Restaurant is located, **on 04th in the month of May 2026** until 2.00p.m. The receipt, obtained upon payment of a non- refundable fee of Rs 2500/= to the Chief Financial Officer in Sri Lanka Railways ,Colombo 10 or the Station Master in the relevant Railway Station, should be produced to the Deputy Superintendent (Sales & Marketing) –Railway Headquarters or the relevant Railway Stations. It should be produced bids separately for each item mentioned in the schedule 01 and it should be placed a refundable bid bond except the bidding application fee as mentioned in the said document. One bidding application is valid only for rest rooms with one restaurant.

03. Submission of bidding applications

The duly, perfect application ,obtained as indicated under the above 02 should be submitted marked as “original” & “duplicate” relevantly in two sealed envelopes & enclosed both in one sealed envelope written as “ Tender Application for Rest Rooms with the Restaurant (Title of the Restaurant with the Rest Rooms)” with the bid number and Title of the canteen on the top left hand corner of the cover should be either sent by registered post to reach the address Chairman, Departmental Procurement Committee, Sales & Marketing Division, Railway Headquarters, Colombo 10 or deposited in the Special Tender Box, available at the official room of the Deputy Superintendent (Sales & Marketing) in the Railway Headquarters before 1.00p.m. **on 05th in the month of May 2026**. Applications, received after the due time will be rejected. Late or lost applications in post will not be considered.

04. Receipt of Bids & Opening

Bids will be opened at the Sales & Marketing Division **on 05th in the month of May 2026** at 1.00 p.m. as cited in the above paragraph 03 & the bidder or one of his authorized representatives can present for this occasion.

05. None of employees in Sri Lanka Railways and their immediate family members are entitled to apply for this purpose.

06. The Departmental Procurement Committee retains the right to the final decision.
