01. Eligibility

Should be a Sri Lankan citizen.

02. Obtaining Bidding Applications

Bidding applications can be obtained from the office of the Railway Headquarters Sales & Marketing or the relevant Railway Station **on 07th in the month of May 2026** until 2.00p.m. The receipt, obtained upon payment of a non-refundable fee of Rs. 2500/= to the Chief Financial Officer in Sri Lanka Railways, Colombo 10 or the Relevant Railway Station should be produced to the Deputy Superintendent (Sales & Marketing) of the Railway Headquarters or the Station Master. Separate bids should be submitted for each stall mentioned in the schedule 01 of the bidding application and it should be placed a refundable bid bond except the bidding application fee as mentioned in the said document. One bidding application could be submitted only for one stall.

03.Submission of bid applications

The duly, perfect application, obtained as indicated under the above 02 should be submitted marked as “original” & “duplicate” relevantly in two sealed envelopes & enclosed both in one sealed envelope written as “Invitation of quotations for the stalls in Veyangoda..... (Number of the Stall)” on the top left hand corner of the cover should be either sent by the registered post to reach the address Chairman, Departmental Procurement Committee, Sales & Marketing Division, Railway Headquarters, Colombo 10 or deposited in the Special Tender Box, available at the official room of the Deputy Superintendent (Sales & Marketing) in the Railway Headquarters before 2.00p.m. **on 08th in the month of May 2026**. Applications, received after the due time will be rejected. Late or lost applications in post will not be considered.

04.Receipt of Bids & Opening

Bids will be opened at the office of Sales & Marketing **on 08th in the month of May 2026** as cited in the above paragraph 03 & the bidder or one of his authorized representatives can present for this occasion.

05. None of the employees in Sri Lanka Railways and their immediate family members are not entitled to submit applications.
